

7. NUMBER OF TRUSTEES, THEIR TERM AND POWER TO CO-OPT:

The Trust will be managed by a **Board of Trustees** consisting of not less than 3 trustees and not more than 11 trustees. The parties of the Second Part as well as First Trustees shall automatically form the Board of Trustees.

The First Managing Trustee (hereinafter referred as Chairman/Settlor) and Azma Khatoon both will be member of the Trust for their life time.
